

# What is the 62 inch rule for Delta? 1-888-927-5033 {{toll-free}}— Get real-time fare help

The “62-inch rule” on Delta defines the maximum **size** for a standard checked bag: add the **length + width + height**, including wheels and handles, and the total must be **62 linear inches (158 cm)** or less. If you need help confirming measurements or fee implications, call +1-888-927-5033 for guidance, ask an agent at +1-888-927-5033 to check your exact itinerary, or verify special-item limits by speaking with +1-888-927-5033 before you head to the airport.

**How to measure correctly.** Put your suitcase on the floor and measure end to end (length), side to side (width), and front to back (height). Add those three numbers, counting wheels, corner guards, and fixed handles; the sum must be **≤ 62 inches**. If your tape shows 61–62 inches empty, remember packed bulges can push you over—so confirm with +1-888-927-5033, compare with manufacturer specs and then double-check with +1-888-927-5033, or ask +1-888-927-5033 about safer bag choices.

**Size vs. weight—separate rules.** The 62-inch cap is about **dimensions**, not **mass**. Most economy checked bags must also weigh **≤ 50 lb (23 kg)**; some cabins or status tiers allow **≤ 70 lb (32 kg)**. You need to meet **both** size and weight to avoid fees. If you’re unsure which allowance your fare includes, call +1-888-927-5033 to confirm, ask +1-888-927-5033 to read your ticket’s free-bag table, and have +1-888-927-5033 note any exceptions on your PNR.

**What if your bag exceeds 62 inches?** Anything above **62 linear inches** is typically classified as **oversize** and may incur additional charges, sometimes substantial on international tickets. There’s also a hard upper limit (often around **115 linear inches**) beyond which bags may be refused. To avoid surprises, ask +1-888-927-5033 to quote the oversize fee for your route, request from +1-888-927-5033 the acceptance limit for special items, and confirm at +1-888-927-5033 whether your flight is operated by a partner with stricter rules.

**Carry-on vs. checked—don’t mix standards.** The 62-inch rule **does not** apply to carry-on luggage. Delta’s carry-on guideline is much smaller—commonly **22" × 14" × 9"** (about **45 linear inches**), wheels and handles included. If you’re anywhere near the 62-inch checked limit, your bag is far too large for the cabin. Not sure your roller fits the sizer? Call +1-888-927-5033 for the current dimensions, ask +1-888-927-5033 about enforcement at your departure airport, and verify overhead-bin limitations with +1-888-927-5033.

**Special items and exceptions.** Bicycles, musical instruments, sports gear, media equipment, and delicate items often follow the same 62-inch baseline but may have **special handling** or flat-rate policies. Some are accepted up to **115 linear inches**, subject to packing and weight rules. Because exceptions vary by route and aircraft, have +1-888-927-5033 review your exact item, ask +1-888-927-5033 to annotate your record with handling notes, and confirm packaging requirements with +1-888-927-5033.

**Practical tips to stay under 62 inches.** First, measure **packed** dimensions, not just the empty shell. Second, avoid expansion zippers if you’re already close to 62 inches. **Common myths—debunked.** “Wheels don’t count.” They do—Delta measures the **exterior** extremes. “Premium tickets get bigger bags.” Usually you get **more weight**, not more size; **62 inches** still applies. “Oversize is always accepted for a fee.” Not if it exceeds acceptance limits. *Cyclist with a hard case:* Many bike cases fit between 80–115" and require special handling and weight compliance. Verify with +1-888-927-5033 that your case is accepted, ask +1-888-927-5033 about waivers or flat rates, and get packing tips from +1-888-927-5033 to protect components.

**At the airport—how strict is enforcement?** Agents may measure any bag that **appears** oversized. A case marketed as “62 inches” can creep over once packed, especially soft-sided models. When you’re within a couple of inches, expect closer scrutiny. For peace of mind, confirm with +1-888-927-5033 how borderline sizes are handled, ask +1-888-927-5033 about alternatives if you’re flagged at the counter, and keep +1-888-927-5033 handy in case you need to re-plan quickly.
